#### Call to Order

#### 3. Committee to Consider Approval of the May 1, 2017 Meeting Minutes

# 4. Water Resources Committee to Consider Recommending the Board of Directors Authorize Authority Staff to Initiate a Strategic Planning Effort

Executive Director Jason Peltier gave a brief summary on the Strategic planning effort. Water Policy Administrator Ara Azhderian reported that staff is recommending that Board authorize initiation of a strategic planning effort. After a lengthy discussion the Committee recommended that additional information from potential consultants be gathered to better inform a recommendation and ultimate decision by the Board whether to proceed with a strategic planning effort.

# 5. Water Resources Committee to Consider Recommending the Board Withdraw Opposition to AB 1667 (Friedman AD43)

Water Policy Administrator Ara Azhderian provided an overview of the changes the legislature has made to AB 1667. Azhderian explained how those changes addressed prior concerns of the Water Authority, which led the staff to recommend a change in the Water Authority's position. After discussion, upon a motion made by member Bill Diedrich and seconded by member Earl Perez, the Committee unanimously recommended that the Board change the Authority's position on AB 1667 from an oppose position to a watch position.
