Member Agencies,

Reclamation has been coordinating with TCCA and the SLDMWA in preparation for contract negotiations for those contractors that have submitted their request (see attached list of contractors) under the WIIN Act to convert water service contracts to 9(d) repayment contracts. This email to give you a heads-up that Reclamation has scheduled a **CVP –wide Technical Session with Contractors on September 26th from 10 am – 3 pm in Sacramento. The location is 650 Capital Mall.** A notice to each contractor will be provided by Reclamation. All contractors should prepare to attend the Technical Session and to identify your agency representative(s) with delegation of authority to negotiate the contract. Although Reclamation will not require you to identify you agency's representatives until prior to the first negotiation session, I would recommend that you have your agency representative attend the Technical Session. At this Technical Session, Reclamation will review the negotiation process/schedule, form of contract, RRA implications, new construction costs, calculation of repayment obligation, etc. If you have specific issues you wish to be addressed at the Technical Session, please provide them to me and I will advise Reclamation. If you wish to contact Reclamation directly, Barbara Hidleberg is the Project Lead. Her email address is: bhidleburg@usbr.gov.

Reclamation anticipates negotiation sessions will begin near the end of the year or beginning of 2019 with the goal is to have all contract conversions completed by December, 2019.

Not all Authority water service contractors are listed as having submitted a request for a contract conversion. If you are not on the list and want to convert your contract, you must send a request to Reclamation in order to be allowed to convert. The first attachment is a list provided by Reclamation identifying all Contractors that have submitted a request for conversion. The second attachment lists all Authority members and highlights those members that have not submitted a request.

Becca and I will work to coordinate amongst Authority members to determine how/what assistance the Authority should provide in the negotiation process. Please feel free to contact me should you have any questions.
