1. Section V. Proposal Documents item #2 (Pass/Fail). What Proposal Documents are required to be responsive to item "2. All required Proposal Documents are included."? Is this intended as a responsiveness check for the items listed, table of contents, or other?
  - **Correct. This is a check to make sure proposers included all of the items listed in the Proposal Contents.**
2. Section I.V Scope of Work Task #4 Final Design Support. Will design specifications need to be developed as part of the Final Design RFP?
  - **No**
3. Section V. Proposal Documents item #6 Project Schedule. The request for a proposed project schedule refers to Section III Critical Dates. These dates are related to the proposal award and not the project. Are there other critical dates that should be reflected in Section III and contemplated in the proposed project schedule?
